We provide solutions in the Civil Engineering and construction, the oil and gas industry, the steel industry, telecommunications and wind energy sectors, where transportation, lifting and handling operations are required to execute works such as:

- Plant unit shutdowns for maintenance.
- Acceptance, transportation & amp; delivery and installation of cooling units, air conditioning, VRV, AHU.
- Full removal of mobile drilling rigs including dismantling, transfer and reassembly.
- Dismantling, transfer and re-assembly of tower cranes.
- Assembly and installation of works of Art and wood or metal constructions such as roof structures, bridges and walkways.
- Removal of production tools from plants or small businesses including the transfer and installation of machines.
- Aeronautical maintenance on jumbo jets, emergency operations and transportation of full fuselage and/or turbojet engines.
